### WILPFers Arrested in Cliffside Protest

### Moncure Strike Ends with Return of Some Workers

**Charlotte, April 20th** – Monday will be a day long remembered for its sense of purpose, community, dedication, and commitment to non-violence. Over 300 gathered in a park in Charlotte for testimonials of people affected by Appalachian mountain top removal coal mining; marched peacefully singing and chanting to the Charlotte of Gov. Perdue; and continued downtown to the headquarters of Duke Energy to present CEO Jim Rogers "A Call To Conscience: People's Injunction To Stop Cliffside." This document and action were endorsed by twenty-one groups and eight notable individuals. (See pg. 2)

Both Rogers and the police were notified of our plans and were prepared. Duke Power marked the sidewalk where city property ended and Duke's began. We were warned that crossing the line meant arrest. Led by conscience, 44 of us crossed the line and were immediately handcuffed, put in paddy wagons, and taken to jail to be processed. In jail around noon, out between 5:30 and midnight. We still have hope that Duke Energy will exercise their collective consciences to stop contributing to the endangerment of the health of all life. **Moncure, April 6** – After negotiating with Moncure Plywood since April 2008, and striking since July 20, 2008, the International Association of Machinists and Aerospace Workers (IAMAW) Local Lodge W369 finally was able to reach a settlement with the management and began returning to work on April 6, 2009. The 106 loyal union members will not all be able to return to work immediately, since the plant has been affected by economic conditions and the absence of the skills of the striking workers. They are and will continue to be returning to work in stages, by seniority (which was one of the issues in the strike.)

Community support for the union strikers began in early August, spearheaded by Triangle WILPF members and spreading to churches, civic groups, and eventually the Board of County Commissioners in Chatham. Mobilizing the International structure of the Union was also key. The supporters visited the 24/7 strike lines, bringing food and drink and good cheer – the occasional song was also heard – and money. The typical Union strike fund payments were sadly inadequate for a strike lasting this long, so fundraising among the constituency of the supporters was an ongoing effort.

Meanwhile, the community support group was raising funds and soliciting the support of the County Commissioners. (see STRIKE, pg. 2)

**A CALL TO CONSCIENCE:  
PEOPLE'S INJUNCTION TO STOP CLIFFSIDE**

April 20, 2009

We, The Responsible Residents Of North Carolina and The United States Of America, and the inhabitants of our endangered planet Earth, do hereby issue this People's Injunction to Duke Energy's CEO Jim Rogers, his staff and Duke's Board Of Directors, requiring them to immediately cease all construction on the Unit 6 coal-burning power plant at Cliffside, in Rutherford County and to direct all efforts toward clean energy.

This Injunction Is Hereby Issued For The Following Causes:

Unit 6 is not and will never be necessary to meet energy demand in North Carolina.

The science-based consensus on the accelerating climate crisis requires that world-wide coal-burning for the purpose of generating electricity be phased out. Cliffside Unit 6 would produce 6 million tons of CO<sub>2</sub> annually for the next 50 years.

The 2.4 billion dollars of rate payers' money being spent on Cliffside must immediately be re-directed toward independent efficiency and conservation programs, as well as the mass deployment of renewable energy technologies.

Mountaintop removal coal mining has leveled more than 470 Appalachian mountains as it has buried or polluted 1,200 miles of pristine headwater streams.

Duke energy is endangering the health of all citizens by refusing to use the best technologies to control hazardous air pollutants including mercury, dioxins, hydrogen chlorides and fluorides, cadmium and others.

**FOR THESE REASONS, IN WITNESS OF THIS AND FUTURE GENERATIONS, THE UNDERSIGNED HEREBY AGREES TO CANCEL CONSTRUCTION AT CLIFFSIDE AND HELP NORTH CAROLINA MEET ITS RESPONSIBILITY TO SUBSTANTIALLY REDUCE GREENHOUSE GAS EMISSIONS.**

A resolution drawn up by one of the support group for the Chatham County Commissioners was passed, and the commissioners agreed to ask the county DSS head to assist the workers in getting assistance, and that the Commission Chair and Vice-Chair meet with the plant management. But the settlement was reached before that meeting could take place.

The final benefit event, scheduled for April 1 at the General Store Cafe in Pittsboro (Many thanks, Vance and Jorjie) actually turned into a victory celebration as well as a fundraiser, since the strike was settled on March 30!

The settlement of the strike was not totally victorious in some ways, but unexpectedly good in others.

1. Seniority was maintained, always a key concern, and in fact is governing the order of return to work.
2. Hours of work per week has been returned to 50 as a standard, but increases required by delivery schedules may be given according to seniority.
3. Health care charges to workers have been increased, but nowhere near the original company demand.

Unexpected provisions:

1. A joint company-worker safety committee, to bring the rising injuries back into line with prior records.
2. A joint company-worker productivity committee, to improve product quality and marketing to improve the position of the company.

The agreement was in place and accepted by the membership before the April 1 benefit at GSC, and so the benefit, while still raising a good bit of much-needed money, turned into a celebration. The Grannies sang, a neighborhood group of adults and children sang, good food was eaten, and a very fun auction, run by former Commissioner Gary Phillips, was held.

Since the settlement, several of the union members have returned to work. There are disturbing reports of the members having difficulties with the management, which is expected since they are practiced union-busters who were temporarily beaten by the worker-community solidarity. Continuation of that solidarity is needed, and we in the support group are watching and listening, and putting on community education events such as will occur Saturday, May 9 (see calendar.)
